Compulsory Capital Levy – \$550 per family per year. Charged as two \$275 levies each year in January and July.

Enrolment Fees

Enrolment Application Fee - \$290

Paid with enrolment application.

Definite Place Fee - \$1,650

Paid to secure your child's enrolment once offer of enrolment is accepted. If more than one sibling is enrolled at the same time, a 10% discount is applicable to the second and all subsequent definite place fees when an enrolment offer is accepted.

Holding Fee - \$1,650

Payable in the event of approved leave of absence of one term.

Family Discounts - Family discounts apply for families with more than one child concurrently enrolled in the School who are not on any other form of discount (e.g. Scholarships). Discount rates are as follows:

- Second child - 2.5% discount
- Third child - 5% discount
- Fourth and subsequent children - 10% discount.

Enrolment Deferral - \$600

Payable in the event of acceptance of enrolment but would like to defer the start date.

Fee Information

Compulsory School Fees

– Are billed monthly due on the 15th of each month.

Fees for Pre-Kindergarten to Year 11 students are paid over a 11-month cycle – January to November. Fees for Year 12 students are paid over a 10-month cycle – January to October.

If accounts are not paid by the due dates, families incur a late payment administration charge of \$50. Direct Debits that are unable to be processed incur a \$15 charge per process attempt.

Withdrawal Fee – As per your signed enrolment contract, if a student is withdrawn before completion of Year 12, the Principal must be advised in writing with one full term's notice. If a term's notice is not provided, a term's fees or a portion thereof will be charged in lieu of notice.

These amounts are a genuine pre-estimate by the School of the loss that it would suffer if the required notice is not provided.

Prepaid Fees – Fees can be paid in advance in December 2025 at a discounted rate of 2.0%. This rate is determined each year by our Board of Governors.

Incidental Fees – Include the majority of curriculum-based charges and those charges that are levied on each student where it applies to the year group. It does not include charges that are incurred on a voluntary and discretionary basis, such as bus charges, uniforms and book list items.

Alumni Lifetime Membership Fee – From 2026, a once-only fee of \$250 will be charged in Year 7. This fee will also be charged in Year 12 until 2030 as a transitional measure. From 2031, the fee will only be charged in Year 7.

Payment Options – All families are required to set up a monthly Direct Debit. Instructions on how to set up will be sent to new families in December of each year.

Additional

Optional Activities – Co-curricular activities such as sports, music, drama and other co-curricular activities as well as bus charges and externally delivered courses incur further costs. These non-compulsory costs are charged to your monthly fee statement.

School Uniforms – Purchased separately from the Pittwater House Uniform Shop.
